



## Food & Beverage Booth Information and Application

The mission of the *Skagit River Salmon Festival* is to celebrate our amazing Skagit River and its vast resources while inspiring community conservation. The event is a fun-filled experience for families featuring youth activities and crafts, recreational and educational booths, live music and cultural opportunities.

Through the day's events and activities, participants will come away with a greater understanding and appreciation of our Skagit River, our salmon resources, and our many communities it sustains.

The 2018 *Skagit River Salmon Festival* will be held from **11 a.m. to 6 p.m., on Saturday, September 7, 2019, at Edgewater Park in Mount Vernon.**

Our food and beverage booth objectives are to provide Festival visitors with a variety of food options, including salmon, and align with the farm-to-table movement at affordable prices.

**What is Farm-To-Table?** The farm-to-table movement advocates for local, seasonal, fresh and organically-produced foods, and is promoted by farmers and restaurants as a means to connect consumers to the source of the ingredients in their meals.

**Booth/Food Truck Fees.** The Festival requires a **\$165 Booth Fee.**

We require food vendors to set up and sell on **September 7, from 11 a.m. to 6 p.m.** There are a limited number of electrical outlets available. **Outlets will be available on request at an additional fee of \$35.**

Please return the attached application as soon as possible if you are interested in participating this year along with the menu you plan to serve. The *Skagit River Salmon Festival* will review all vendor applications and make a determination of appropriateness and acceptance. We also need to know if you have any unusual electrical requirements.

**Please note that you MUST have current a food handler card, business license, catering permit, and pass inspection by the Skagit County Health Department.**

**ZERO WASTE**

The Festival organization is committed to promoting the preservation and conservation of the Skagit River as an invaluable community resource. Therefore, we participate in the **Skagit County Zero Waste Events Program. All food service-ware and drink containers must comply with the Zero Waste Vendor Packaging Rules.**

\_\_\_ **Insurance.** A Certificate of General Liability Insurance is **required**. Ask your insurance provider to e-mail your Certificate of General Liability Insurance to [skagitriverfest@gmail.com](mailto:skagitriverfest@gmail.com). **Deadline for submission is July 19, 2019.**

The Certificate of General Liability Insurance must cover \$1,000,000 minimum, naming the Skagit River Salmon Festival as Certificate Holder for the date of **September 7, 2019**. Certificates must be emailed or mailed to arrive no later than **July 19, 2019**, if you have questions about the insurance requirement, please contact your insurance provider.

\_\_\_ I agree to keep my booth open and in operation during the Festival hours Saturday, September 7, 11 a.m. – 6 p.m. No booths shall be taken down prior to 6 p.m. In case of a real emergency, contact the Festival to negotiate a mutually beneficial arrangement. I understand that if I do pack up my booth and leave Festival grounds prior to 6 p.m. without notifying a Festival official, it is considered a breach of contract and that any future application will not be considered.

# Vendor Packaging Rules

Updated Spring 2017

## How can you package food items? Make sure food service-ware is compostable!

### **YES: Strongly Recommended**

Provide your food products in **uncoated paper** packaging and containers, for example:

- Wax paper
- Uncoated paper plates
- Paper napkins
- Paper towels
- Bamboo forks, knives, spoons
- Unlined/uncoated paper boats
- Unlined/uncoated paper bowls
- Unlined/uncoated paper bags
- Unlined/uncoated paper clamshells
- Large condiment dispensers

### **NO: Strongly Discouraged**

We ask you **not** to use non-recyclable materials to package your food products. For example, do not use:

- Styrofoam
- Foil
- Saran Wrap
- Plastic Forks, Knives, Spoons
- Individual Condiment Packages
- Plastic straws (when possible)
- Plastic bags

---

## How can you provide drinks? Make sure drink containers are recyclable!

### **YES: Strongly Recommended**

Provide drinks in recyclable containers, for example:

- Plastic bottles, #1 and #2
- Aluminum cans
- Clear plastic cups with lids
- Red plastic cups
- Paper coffee cups
- Paper cartons

### **NO: Strongly Discouraged**

We ask you **not** to provide drinks in any of these containers:

- Styrofoam cups

## FAQ

### **How can I tell the difference between a lined or coated paper product and an unlined or uncoated paper product?**

Lined and unlined paper products are sometimes difficult to tell a part. A lined paper product has a very fine plastic lining across it to give it better structure, and prevent food from soiling through the surface. An unlined paper product does not have this plastic lining, and is sometimes slightly thicker as a way of preventing food from soaking through the surface.

Some general guidelines to identifying lined paper are if they have a design or print on them (paper plates with flowers, for example), or have a shiny or waxy coating on the outside surfaces. It may be helpful to know that all paper cups used to serve coffee are lined on the inside, and cannot be composted. However, if emptied of the beverage they contain, paper coffee cups can be recycled as mixed paper.

If you are still unsure whether a paper product is lined or not, you can do a 'scratch test.' Scratch the surface of the product where you believe the liner to be, if you see an indent where your fingernail has been (not into the paper, but into the liner), then you know it is lined.

The exception to this is waxed paper. Wax, being a natural substance, is compostable and can be accepted as a package to serve food at a Zero Waste Event. Make sure that your paper is truly waxed before using it to serve food.

### **Why aren't paper cups compostable?**

Paper cups are not compostable because they are often lined with a very thin plastic on the inside of the cup. This prevents the beverage from soaking through the cup, and gives the cup a longer usage time by the consumer.

Since plastic does not break down and return to soil, paper cups cannot be composted, and must be emptied and recycled as mixed paper.

### **Why aren't you accepting compostable plastics in the compost catchment?**

We no longer accept compostable plastics in the Zero Waste Event compost catchment, because despite best efforts, compostable plastics are not breaking down in the industrial composting systems. This is happening all around Washington State. Rather than contaminate soil enriching compost, we want to keep the soils that the composting industry is making as clean as possible. Single use plastic is a problem everywhere, we want to do our best to reduce the impact it is making.

We find that unlined and uncoated paper products do break down in the industrial composting system, as do bamboo forks, knives, spoons, paper towels, paper napkins, and waxed paper. We recommend these paper products over any type of compostable plastic service ware.
